



2012 Miss La Cañada Flintridge Contest Rules & Regulations

The young lady selected for this honor, along with her Court, will be a representative of La Cañada Flintridge for various community events and activities throughout the year. Their reign begins in January 2012 and ends in January 2013. Miss La Cañada Flintridge will receive a \$500 scholarship and each Court member will receive a \$250 scholarship from the La Cañada Flintridge Chamber of Commerce and Community Association, along with several gifts from local merchants.

To launch this special celebration, the LCJWC will be hosting a "Kick-Off" reception on Tuesday, September 20th at the Thursday Club on Woodleigh Lane from 6:00-7:00 p.m. All applicants are encouraged to stop by and "meet and greet" the ladies of the LCJWC and members of the LCF Chamber of Commerce.

Please read the following rules and qualifications for the Miss La Cañada Flintridge Court. If you would like to be considered, complete and return the attached application, along with a **\$75 application fee** (check payable to L.C.J.W.C.) and a photo, to the La Cañada Flintridge Chamber of Commerce office no later than **5:00 p.m.** on **September 22nd, 2011**. Participation in the Miss LCF pageant includes an etiquette workshop to be held on Thursday, September 29th at the Flintridge Bookstore from 7:00 - 8:30 p.m. Interview skills, visual poise, applications and more will be addressed as well as a "Q and A" with the 2011 Court.

All applicants will be interviewed on **Thursday, October 6th, 2011** and finalists on **Thursday, October 13th, 2011**. The Court will be announced on **December 2nd** at the Festival in Lights celebration. Miss LCF will be announced and crowned at the Coronation Ceremony on **January 19, 2012**, at the La Canada Flintridge Country Club.

1. Applicants must be currently enrolled in the 11th grade as of January 2012 and a **resident** of La Cañada Flintridge.
2. Applicants must be willing to serve as an official representative of La Cañada Flintridge and its Chamber of Commerce, participate in publicity photos, promotional events, and assist in fundraising activities throughout the year.
3. Applicants must be able, available, and fully agree to participate at various civic functions. These would include ribbon-cutting ceremonies, Chamber mixers (held the 3rd Thursday of each month), Fiesta Days Memorial Day Weekend Celebration, Montrose Christmas Parade, and miscellaneous city organization and Chamber sponsored events.
4. Applicants must be available for Court wardrobe fittings, Coronation Ceremony and preparation, group pictures and individual portraits.
5. Applicants will be judged on academic/special achievements, communication ability, community service, personality, poise, and personal interview.
6. If selected to the Court, each young lady will be expected to conduct herself in a manner consistent with the honor of her title, including good moral judgment, self-respect and respect for others at all times. Applicant and a parent will read, sign, and honor the "Code of Conduct" agreement received at the initial interviews.
7. All Court wardrobes are provided for the exclusive use of Court related events until after the year of reign is completed. Donated clothing is not to be worn outside of Miss LCF Court functions.
8. Applicants will carefully read the instructions for application and follow them while meeting the deadline.
9. Correspondence is done via e-mail for all interviews and Court communication. Applicants must check and respond promptly to all e-mails received from the Miss LCF Coordinators.
