Members of each city commission, committee and council shall be appointed by a majority vote of the total City Council. Each member of a city commission shall serve at the pleasure of the City Council.

The Design Commission of the city shall consist of five members. One member should be an owner or manager of a business within the city; said member need not reside in the city. Aside from the business member, if any, all members shall be city residents. At least one member should be licensed in the state of California as an architect, or retired from that status. At least one member should be professionally qualified in horticulture or landscape construction, with preference toward a member licensed in the state of California as a landscape architect, or retired from that status. At least one member should be qualified in a related field, including but not limited to urban planning, urban design, historic preservation, industrial design, interior design, building construction, or real estate development.


