

RESOLUTION NO. 92-43

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE
ESTABLISHING A PUBLIC FACILITIES FEE SCHEDULE FOR PUBLIC USE OF THE
FACILITIES UNDER JURISDICTION OF THE CITY OF LA CAÑADA FLINTRIDGE**

WHEREAS, the City of La Cañada Flintridge, through a Joint Powers Agreement with La Cañada Unified School District, has incurred costs of providing operation, maintenance and capital improvements in connection with public use of those facilities under the jurisdiction of the City of La Cañada Flintridge; and

WHEREAS, the schedule of fees represents reimbursements for such costs incurred by the City allowing use of those facilities; and

WHEREAS, it is equitable that the City of La Cañada Flintridge be compensated for providing facilities for public use; and,

WHEREAS, there are a limited number of facilities available for use in the City of La Cañada Flintridge; and

WHEREAS, the La Cañada Unified School District incurs the cost of operating lights at La Cañada High School, yet the City of La Cañada Flintridge provides scheduling of users at this facility for the La Cañada Unified School District; and

WHEREAS, a user billing schedule for reimbursement of costs associated with operating lights for private users must be provided by the City of La Cañada Flintridge to the La Cañada Unified school District for the School District's billing process;

NOW, THEREFORE, the City Council of the City of La Cañada Flintridge hereby resolves as follows

That certain "Public Facility Fee Schedule" attached hereto as Exhibit A and incorporated herein by reference is adopted as the fee structure in connection with public use of those facilities under the jurisdiction of the City of La Cañada Flintridge; and

That Resolution 91-25 is hereby rescinded.

EXHIBIT A

CITY OF LA CAÑADA FLINTRIDGE
PUBLIC FACILITY FEE SCHEDULE

A. Sites

1. All athletic and tennis courts described in the Joint Powers Agreement between the La Cañada Unified School District and the City of La Cañada Flintridge are directed by this resolution.
2. All parks within the City limits of La Cañada Flintridge are directed by this Resolution.

B. Fees and Billing Procedures

1. The following rates apply to the respective facilities;

| Tennis Courts | \$10.00/hour per court |
| Athletic Field | \$25.00/hour per field |
| Lights for Athletic Field | \$20.00/hour per field |

2. The City Manager or designee shall send a copy of the approved permit to the La Cañada Unified School District maintenance office for electrical billing by the District to the user group.

C. Fee Waiver

In some cases, it may be deemed by the Parks and Recreation Commission that a user group's fee may be waived if the group volunteers labor or materials of a value equal to or greater than the amount of the fee. A waiver of fees will be considered upon application to the Parks and Recreation Commission.

D. Damages and Cleaning Fees

1. Any person or group causing property damage will be required to pay for damages based on actual costs of repair or replacement including any staff time incurred.
2. A cleaning fee of \$25.00 per hour will be charged to any person or group if a field or facility is left in an unacceptable condition, i.e. trash not picked up, graffiti present, or any other condition as not the same as before using the site. This fee will be charged after cleanup.
